6. MBK-Informational briefing on options for the future District:

Ric Reinhardt addressed challenges and opportunities for meeting on OMRRR&R obligations. He presented his memo of July 29, 2020, see attached. Currently \$133,000.00 annually budgeted. MBK proposes doubling that budget.

- Insufficient revenue to perform OMRR&R without Flood Maintenance Assistance Program (FMAP) funding.
- No financial reserve, making it difficult to cashflow routine maintenance activities and not being prepared for an unexpected expense or known future expenses, such as replacing the pump station.
- The District and property owners have conflicts with the proposed large fish passage project at the Fremont Weir.
- Concerns with seepage, sloughing, cracking, and insufficient freeboard on the Yolo Bypass levee.
- Concerns with erosion, seepage, and stability of the Sacramento River levee.

7. <u>Update on Yolo Bypass slip repair:</u>

Tina Anderson reported that budget increased to \$711,000.00 repairs and requested from DWR an additional \$500,000.00. Will prepare bid and package. Going to expedite contract extension. Upon motion duly made by director Kent Lang, seconded by Nick Zanotti to authorize the signing of the contract. Ric recommends advertising for bidders

8. Update and action on FMAP:

Tina Anderson reported on FMAP \$15,000.00 still available for O&M. SWIF and 218 election –engineer's report.

Upon motion duly made by Director Michele Clark, seconded by Director Nick Zanotti and unanimously passed Tina Anderson, DWR inspection report.

9. Manager's report:

Kyle Lang reported Emerald finished about half of their job. Kyle Lang reported on Emerald tree trimming, half way through. No burn

permits available. Discussed with EFPD managing the burn. Weed spraying is working well. Gates on river levee are being bypassed. Bids will be obtained to extend the gates to prevent this activity a storage container has been received and will be stored on TeVelde property.
